#### THE HEARING AID COVERAGE ACT of 2015

There is a new Bill in Congress: THE HEARING AID COVERAGE ACT of 2015. The legal title is HR 1653. This Bill will change the Medicare rules. If this Bill becomes law, then MEDICARE will pay for HEARING AIDS for anyone under MEDICARE. This law will save people thousands of dollars.

### **RAISE Family Caregiver Act Introduced in House & Senate**

The Recognize, Assist, Include, Support, and Engage (RAISE) Family Caregivers Act (S. 1719) was introduced in the Senate on July 8, by Senators Susan Collins (R-ME) and Tammy Baldwin (D-WI). It's companion bill, (H.R. 3099) was introduced in the House the following week by Representatives Gregg Harper (R-MS) and Kathy Castor (D-FL). The bipartisan RAISE Family Caregivers Act would require Congress to develop a national strategy to support family caregivers. It would also create an advisory panel that would bring together federal agencies, as well as public and private organizations that would advise and make recommendations on issues around how to recognize and support family caregivers. # One Social Security Act Introduced in the House of Representatives

Last week, Representative Xavier Becerra (D-CA) introduced the One Social Security Act (H.R. 3150). The bill would avert a 19 percent across-the-board cut to Social Security Disability Insurance (SSDI) benefits at the end of 2016 through merging the Social Security Old-Age and Survivors Insurance (OASI) and Disability Insurance (DI) Trust Funds into a single Trust Fund. The U.S. Access Board released a new installment of its online guide to accessibility standards under the Americans with Disabilities Act (ADA) and the Architectural Barriers Act (ABA). The material features a series of technical bulletins covering requirements for accessible routes in Chapter 4 of the ADA and ABA Standards, including doors and gates, ramps and curb ramps, and elevators and platform lifts. #### **New Tactile Braille Tablet on PC Platform**

From Path to Literacy

**Insidevision** is a French company developing a new generation of braille note taker with its tactile braille tablet. This video (without sound) provides an introduction to the product. The tablet includes many features such as a LED light source, multiple USB ports, HDMI hook up, microphone, and a camera. The tablet runs on the Microsoft Windows platform and has several common apps including notes, word processing, contacts, maps, mail, and cloud storage to support communication and access to information.

The tablet uses commands in different languages, including UEB (Unified English Braille). The device uses a specific finger print on gorilla glass to access the braille notetaker on a flat screen.

The product is scheduled to be released in October 2015 and will sell for 6000 Euros.
